Badges

A badge will be issued to each licensee which shall state "LICENSED, CITY OF HONDO," the period for which the permit is issued and the number of the permit, in letters and figures easily discernible. Licensee is required to wear this badge constantly in front of his/her outer garment where it may be visible to the public.

Fees

(a) Peddler, Vendor and Solicitor permit fees are as follows:

- (1) 30 day permit = Twenty Five Dollars (\$25.00)
- (2) 60 day permit = Fifty Dollars (\$50.00)
- (3) 180 day permit = Sixty Five Dollars (\$65.00)
- (4) One year (12 months) permit = One Hundred Dollars (\$100.00)
- (5) Each additional agent(s) to be working in the city, an additional fee of twenty five dollars (\$25.00) per agent shall be required.

- (b) If permit is lost, a replacement shall be issued for the remainder of the term of the original permit only upon payment of an additional fee of fifteen dollars (\$15.00), said fee to offset the administrative costs involved.
- (c) Persons duly engaging in interstate commerce are specifically exempted from the fee requirements herein, but shall comply with all other registration and permitting requirements.
- (d) There is no fee for a canvasser requesting a permit or a replacement permit if *the primary purpose is to enlist support for or against political party, issue or candidate, religion, philosophy, ideology or distributing handbills or flyers advertising non-commercial event or service.*
